Please read this Privacy Policy carefully. When accessing our website and our specialised platforms, the provision of your personal data implies knowledge of this Privacy Policy, as well as the policies and conditions of the entity providing the services to you through the specialised platforms.

Who is responsible for collecting and processing data?

MULTICERT - Serviços de Certificação Electrónica, S.A., (hereinafter referred to as Multicert) is the entity responsible for the collection and processing of personal data related to the purposes specified below, and may, within the scope of its activity, use subcontracted entities to pursue the purposes indicated herein.

What is personal data?

Personal data is any information of any nature and regardless of its support, including sound and image, relating to an identified or identifiable person. Any person who can be identified directly or indirectly, through an identification number or one or more specific elements of his / her physical, physiological, psychic, economic, cultural or social identity, shall be considered identifiable.

What personal data is collected and processed?

You can browse through Multicert's website without providing us with any personal data. When you fill out our forms, Multicert collects and processes, among others, the following personal data: name, telephone number, address and e-mail address or IP address. In the case of job applications, we collect and process personal data contained in CVs and/or motivation letters sent to us.

In any case, Multicert only collects the data necessary for the purposes for which they are intended.

Personal data collected in this website will in no case be made available, sold, shared or revealed to third parties, nor used for any purposes other than those described at the time of collection, or within the scope of this Policy.

Multicert assumes that the data has been provided by the holder of the data or that he/she has given consent to this effect and presumes that the data is true and up to date.

How is your data collected?

Personal data may be collected by the following means:

- a) e-Mail;
- b) Website;
- c) Chat;
- d) Telephone Calls
- e) In person;
- f) Social Media.

The data collected is processed and stored electronically, in strict compliance with data protection rules. Data is stored in a specific database, created for this purpose, by Multicert or by the entities subcontracted by it.

Some of the personal data collected on the website is mandatory and, in case of lack or insufficiency of such data, Multicert may not be able to provide you with the services or information requested. In each case, Multicert will inform you of the mandatory nature of the provision of the personal data in question.

What are the purposes and legal basis for processing your data?

In accordance with data protection principles Multicert may only process your personal data for specific purposes and if it has a legal basis to do so. Multicert uses your data for the following purposes and on the basis of the following grounds:

- I. Because we are within the scope of a contract or at pre-contractual measures we process your data for the purposes of:
 - a. Issuing digital certificates, renewals and management of the contractual relationship;
 - b. Invoicing;
 - c. Registration of New Customer Account on the website;
 - d. Contact request "DO YOU HAVE ANY QUESTIONS?";
 - e. Request for information "online chat";
 - f. Technical support;
 - g. Recruitment and selection of candidates in current job offers;
 - h. Analysis and evaluation of spontaneous applications:
 - i. Download e-books;
 - i. Registration in webinars:
 - k. Holding events.
- II. On the basis of your consent we process your data for the purposes of:
 - a. Sending you information regarding future opportunities such as training initiatives, internship programmes and/or job vacancies;
 - b. Sending direct marketing and newsletters, if your consent is collected on the website;
- III. Because we are required to comply with the law, we process your data for the purposes of:
 - a. Complaints;

b. Compliance with other legal or regulatory obligations.

IV. Because we have a legitimate interest in wanting to provide you, increasingly, with a better service, we process your data for the purposes of:

- a. Sending direct marketing and newsletters (if a pre-existing relationship exists);
- b. Generating statistics and measuring website activity for the benefit of users;
- c. Conducting market research, evaluation surveys and statistical analyses;
- d. Social Listening, which allows us to identify, analyse and respond to suggestions and interactions that you may have with Multicert on social networks. drawing up commercial profiles in order to create content that is of interest to our clients.

In order to pursue the purposes identified above, Multicert may interconnect the data collected for the purpose of updating and completing such data.

With whom is your data shared?

The data collected and held by Multicert may be transmitted, complying with the duty of confidentiality and the purpose limitation principle, to the following entities:

- a) Companies or entities in which Multicert has a stake, which participate in its capital, or which are part of its business universe.
- b) Judicial or administrative authorities, in cases where such a cession is mandatory;
- c) INCM (Imprensa Nacional Casa da Moeda) in the case of the complaints book:
- d) Recruitment and selection companies;
- e) Subcontractors who will process the data on behalf of Multicert and according to the purposes defined by Multicert.

"COOKIES"

For how long is your data stored?

The period of time during which the data is retained and stored differs in accordance with the purpose for which the data is processed. Is your data safe?

Multicert is committed to ensuring the protection and security of your data. To that end, Multicert has adopted a series of technical and organizational security measures in order to protect the personal data you make available to us, against its unauthorized diffusion, loss, misuse, alteration, treatment or access, as well as against any other form of illicit treatment.

Multicert requires its subcontractors and its partners to adopt safety measures equivalent to those it practices. In which situations can your data be communicated?
